### Textbook

The Enjoyment of Music, 12<sup>th</sup> edition, by Forney, Dell'Antonio, and Machlis. This textbook is provided by Jackson College as part of the course curriculum.

### Course Description

Lecture and directed listening on the elements, forms, and historic chronology of Western music.

### Course Goals

To equip students with tools to listen to and appreciate multiple genres of music; to increase comprehension of musical form, style, and other musical concepts; and to recognize the historical development of Western music.

### Course Objectives and Outcomes

Students will understand why different musical compositions create different emotions, observe linkages between music and art as reactions to societal (social, political, artistic, and religious) movements, and recognize musical genius through study of works by least two influential composers from historical periods (AD).

In coordination with JC's General Education Committee, MUS 131 has adopted GEO #6, understanding aesthetic experiences and artistic creativity. These competencies are further articulated below, and applied to our course:

Understanding aesthetic experience and artistic creativity (GEO #6)

- Meaning and Understanding – Uses visual, musical, or literary vocabulary to identify works of art and organizes by basic historic and cultural influences
- Analysis and Interpretation – Identifies methods of analysis and interpretation of works of art and uses genre-specific language to support critical reflection
- Engagement – When prompted, engages in discussions of the creative, cultural, and historical contexts within which an artist works
- Approaches works of creative expression with a combination of resistance and interest, disinterest and interest which is expressed in formal discussion or writing

## Student Responsibilities

Students are expected to be considerate and respectful to others.

Students are expected to participate in all class activities and assignments, and to do their own, original work. This includes:

- 1) Watching all Video Lectures, with all included music performances.
- 2) Reading all assigned chapters, and turning in summaries of each chapter.
- 3) Writing all Short Papers assigned, and turning in the papers.
- 4) Responding once a week to Dr. Hintze's J-Pay emails, answering the questions and responding as a way of showing attendance in the class.
- 5) Turning in assignments at the assignment drop location and by the assignment due dates.

Throughout the semester, outcomes will be measured through graded demonstration of understanding (assignments, class participation, papers, etc.). See the class schedule below.

## Attendance- Participation Policy

In compliance with Federal Title IV funding requirements, as well as college initiatives, reporting of student participation in classes will occur continually each semester. Instructors will report to the college regarding individual student attendance. Students identified as “struggling” or “no longer participating” may be identified as needing assistance, or administratively withdrawn from the class.

### Attendance Factors

- **Attendance will be taken** by J-Pay email responses once a week. **Failure to respond the first week, or any 2 weeks in a row, may result in being dropped from the class.**
- After 58% of the class has taken place, the instructor cannot drop you from the class. Students who need to withdraw from our class for *any* reason are responsible for contacting navigators to complete this process to avoid unwanted fees or reporting of failing grades.

### Distance Learning:

Just as in a traditional classroom course, regular class participation and keeping up on the reading and assignments is strongly correlated with survival in college. It is my recommendation that you plan to do your assignments and take your exams BEFORE the last day they are due. If problems occur, there is time to fix them before the deadline.

In compliance with Federal Title IV funding requirements, as well as college initiatives, I will be monitoring student participation on a regular basis and officially reporting student activity throughout the term to assure compliance with college policy and federal regulations. It is imperative that you contact your Success Navigator immediately if you desire to drop or withdraw from the course. Being withdrawn from a course can have an impact on financial aid, billing, athletic eligibility, and housing status. As a college student you are responsible for how your participation impacts your academic progress; the accountability lies with you.

### Utilizing JPAY Email Services

All JPays are closely monitored by the MDOC. It is expected all communication will be related to the student's education and coursework. No personal information may be shared. Personal information is considered inappropriate and will be flagged. A student may be removed from the Jackson College Corrections Education Program for violation of this policy.

JPays may not include attachments, including photos, videos or other material.

Students will use JPay to communicate with the instructor throughout the semester. The instructor will add the student to their JPay account. This communication may be used to:

The expectations for communication between instructors and students in a specific course are:

- 1) Students will communicate questions or seek clarification on course-related content only
- 2) Students will only share questions related to their own coursework. Other students or their work will not be discussed in JPays.
- 3) Instructors will normally respond to student JPays within 24 business hours.
- 4) Instructors may use JPay to provide feedback to students on course assignments
- 5) Students are expected to use professional communication skills in their JPays to instructors: clear, concise writing; correct spelling and language appropriate to an academic setting.
- 6) Please be sure to put the instructor's last name and course information, i.e. Smith, BUA 100, in the first line of the JPay.
